

## Terms and Conditions

The illi App is property of NFORUM EXECUTIVOS FORMAÇÃO E CONSULTORIA, UNIPessoal, LDA., (hereinafter referred as “NFORUM”), Headquartered at Rua da Holanda, n.º 1, 2775-405 Carcavelos, Portugal, under the single company registration number 510 041 477.

The illi App is referred to hereinafter as the “App”.

On using the App, you undertake to comply with the following Terms and Conditions and any changes to the same. You should access this Terms and Conditions on a regular basis to ensure you are familiar with any amendments. If you disagree with these Terms and Conditions, you are not authorized to use the App and should exit immediately.

The use of the App is entirely free of charge.

Users of the App declare and guarantee that they will use the App in accordance with these Terms and Conditions and that they will not disrespect or breach the rights of any other party or fail to comply with any legal agreement or obligation with regard to other parties, or break any applicable law in force.

Users of the App declare and guarantee that all the personal information supplied during the registration process as a user of the App is complete, accurate, up-to-date and true.

Users of the App declare and guarantee that all the information and content supplied during the use of the App:

- is not fraudulent;
- does not breach any copyright, brand names, patents or other intellectual or industrial property rights belonging to third parties;
- does not breach any legal or administrative regulation;
- is not defamatory, libelous, offensive or intimidating;
- is not immoral, obscene or pornographic;
- does not contain computer viruses or any computer files or programs which might damage, or in any other way interfere with the functioning of the App and its data in a negative manner;

### **Collection of personal information**

NFORUM keeps and processes the following personal data of registered users of the App:

- User name;
- E-mail address;
- Family nickname;
- Food allergies from all family members, generalized;
- Food preferences from all the family members, generalized;
- IP address.

The App also collects the following information (not treated as personal data):

- Days and number of recipes per meal plan;
- Meal plans created over-time;
- Meal plans that are deleted;
- Recipes marked as favourite;
- Recipes that are marked as done;
- Login sessions;
- Shopping lists;
- Comments on shopping list;
- Shopping list export;
- Meal ratings;
- Meals that are substituted within a meal plan;
- Meals that are deleted;
- Custom items added to a Shopping List;
- Shopping list items marked "check";
- Page visits within the app.

The data that is collected and processed by the App is used to provide the users with its service benefits and functionalities.

By sharing the above-mentioned data, the users enable the App to deliver the following functionalities:

1. Creating a family account;
2. Create a family profile so we can build custom automatic meal plans, that can be edited over-time;

3. Generate an automatic meal plans, that can be edited and deleted partially or entirely. With the continue usage of the app, meal plans generation will be optimized based on the app usage;
4. Inside the meal plans, users will be able to explore the recipes:
  - a. Change recipes;
  - b. Mark recipes as “done”;
  - c. Rate recipes;
  - d. Mark “favourite” recipes;
5. As a result of the meal plans, the app generates an organized shopping list with all the ingredients from the entire meal plan.

There is no other processing of personal data is done by the App.

The App also uses users’ personal information for unnamed statistical processing with a view to the production of statistical reports, studies and analyses, with no way of individually identifying the users whatsoever. This processing of data and the development of models based on this information may be conducted by external suppliers.

NFORUM does not provide the personal information collected from users of the App to any third parties in any manner whatsoever, neither free of charge nor in return for payment.

The statistical reports, studies and analyses produced based on the information collected by the App may be provided to third parties with no way of individually identifying the users whatsoever, either free of charge or in return for payment.

NFORUM has adopted security procedures to protect the personal information supplied by users of the App.

### **Amendments**

NFORUM reserves the right to revise this Terms and Conditions and the Privacy Policy at any time at its sole discretion, whenever deemed necessary. If the alterations to the Terms and Conditions or to the Privacy Policy seriously affect the personal information already obtained from the users of the App, NFORUM will take the measures it regards as reasonable and appropriate to notify these users of the changes and the option to alter or cancel their registration on the App.
